2. Our fee in conjunction with this format, combined with a five dollar (\$5.00) processing fee per composition, **shall be for a total of ONE HUNDRED TEN DOLLARS (\$110.00).**
Favored Nations: Should Licensee pay to any other licensor a higher rate of royalty than the royalty rate specified above, Licensee shall also pay ALFRED such higher royalty and this Agreement shall be deemed as having been amended automatically.
3. This Agreement does not authorize or permit any use of the Composition(s) not expressly set forth herein.
4. Licensor warrants that it has the right to grant this Agreement and this Agreement is given and accepted without any other warranty or recourse.

5. Licensee warrants that it shall indemnify and hold ALFRED free and harmless from any and all costs, damages and losses, including reasonable attorney's fees arising out of any breach or failure of any agreements or covenants made by Licensee hereunder.
6. Licensee acknowledges that ALFRED is the administrator of the Composition(s), and Licensee will not attack ALFRED's administration thereof. Licensee shall not have the right to grant any sublicenses for the use of the Composition(s) except as herein without the prior written approval of ALFRED.
7. ALFRED reserves all rights not expressly granted to Licensee hereunder.
8. The entire cost of producing and offering for sale (including all preparation and production expenses for artwork, arranging, engraving and printing costs) shall be Licensee's expense.
9. Nothing contained herein is intended to constitute a partnership or joint venture between the parties hereto, it being understood that the relationship between ALFRED and Licensee shall be that of independent contractors and Licensee shall have no authority to bind ALFRED in any way to any third party.
10. ALFRED warrants and represents that ALFRED has the right to enter into this Agreement and to grant all of the rights herein granted to Licensee, and that exercise of such rights by Licensee in accordance with the terms and provisions of the Agreement shall not infringe upon the copyright, property, privacy, contractual or other rights of, or constitute unfair competition with, any third party.
11. Licensee shall have no obligation to arrange, print, record, publish, tape and sell hereunder; provided, however, that in the event Licensee fails to utilize these rights after twelve (12) months following the date hereof, the term of this Agreement shall automatically terminate as of the end of such twelve (12) month period.
12. The Agreement shall be binding upon and shall inure to the benefit of the parties hereto and its respective successors and shall not be assignable (except by ALFRED to any party acquiring all or substantially all of the business assets of Alfred Publishing Co., Inc.)
13. The Agreement represents the entire agreement between Licensee and ALFRED and may only be modified or terminated by an agreement in writing signed by Licensor and ALFRED. The Agreement shall be governed and construed under the laws of the State of California applicable to agreements executed in and to be wholly performed within the State of California and any legal action concerning this Agreement shall be heard in the State or Federal Courts located in Los Angeles County, California.
